Indicator 1: high risk food premise inspections

Indicator 2: pool and spa inspections

Indicator 3: small drinking water system inspections

Indicator 4: time to initiation of gonorrhea case follow-up

Indicator 5: time to initiation of invasive Group A streptococcus follow-up

Indicator 7a: percent wastage Human Papillomavirus (HPV) vaccine

Indicator 7b: percent wastage influenza vaccine

Indicator 9c: percent of school-aged children with completed vaccination for meningococcus

Indicator 10: percent of youth (12-18) who have never smoked a whole cigarette

Indicator 11: percent of tobacco vendors in compliance with youth access legislation

Indicator 12: fall-related emergency visits in older adults (65+)

Indicator 13: percent population (19+) exceeding low-risk drinking guidelines
