An RFP has been done for the remediation work which specifies what portion the City of Port Colborne will be responsible for in the clean up. She shared that approximately 89% of applicants that are on the chronological waitlist do not have special priority status. It was also shared that there are currently 232 NRH tenants who are over-housed with no available units to move them to. M. Waddington advised the Board that there have been a couple of

successes where tenants were able to graduate out of market rent and apply to the Welcome Home Niagara program for down payment assistance to purchase home of their own.
