1. **CALL TO ORDER**

Committee Vice Chair Davies called the meeting to order at 1:01 p.m.

2. **DISCLOSURES OF PECUNIARY INTEREST**

There were no disclosures of pecuniary interest.

3. **STATUTORY PUBLIC MEETING UNDER THE PLANNING ACT**

At 1:03 p.m. Committee Vice Chair Davies called the Statutory Public Meeting under the *Planning Act* to order and stated that the meeting was being held in accordance with Section 17 of the *Planning Act*.

Committee Vice Chair Davies advised that the proposed amendment affects lands legally described as part of lots 119, 120, 136 and 137 in Niagara Falls and the site is located along the western boundary of the City of Niagara Falls, between Thorold Townline Road and Beechwood Road, North of a hydro one corridor.

The proposed amendment consists of text and schedule changes and would add the subject lands to the site specific policies of the Niagara Official Plan to facilitate the establishment of a new quarry.

The Committee Vice Chair stated that any person who wished to make representation on the proposed amendment would be given an opportunity to do so. He additionally advised that written submissions may be submitted to the Clerk's Office to be placed on a public agenda and become part of the public record. Personal information will be collected and maintained for the purpose of creating a record and may be available to the general public pursuant to the *Municipal Act*, the *Municipal Freedom of Information and Privacy Act*, and any other relevant Acts.

3.2 Speakers to the Matter

3.2.1 Donna Boksa

Donna Boksa, Resident, City of Niagara Falls, appeared in opposition to the Official Plan Amendment expressing concerns regarding the health and safety risks for the environment, the ecosystem, and the surrounding community.

Debra Walker, MHBC, appeared on behalf of Walker Industries Inc., the applicant, to provide information on the application including the proposed Upper's Quarry site details, land use compatibility and their commitment to the community, surrounding land, and rehabilitation efforts.

David Falletta, Bousfields Inc., appeared on behalf of Rudanco Hospitality Corporation, owners of 13030 Lundy's Lane, to request modifications to the application to reflect the Rudanco Lands as a sensitive land use; the inclusion of provisions such as utilizing sensitive extraction methods, coordinating phasing of the quarry, establishing haul roads, implementing berms and the delay of the Official Plan Amendment until these mitigation measures can be addressed.

Helene Cayer, Resident, City of Niagara Falls, appeared in opposition to the Official Plan Amendment expressing concerns regarding zoning by-law changes over the last 20 years and a lack of consistency and transparency for inquiring residents.

Frances Chandler, Resident, City of Niagara Falls, appeared in opposition to the Official Plan Amendment expressing concerns regarding changes to land use planning, health of the community and the destruction of agricultural lands.
