As discussed on the phone, the Province is directing a certain amount of population and employment growth to the Region to 2051. The Region has, in consultation with local municipalities, undertaken a review of growth trends and development potential across Niagara to determine how this growth will be allocated to each local municipality.

Fort Erie has been allocated a 2051 population of 48,050 based on housing growth of 7,360 units between 2021 and 2051. At 50% intensification, this means the municipality shall plan to accommodate a minimum of 3,680 new housing units within the already developed (built-up areas) across all communities in the Town of Fort Erie by 2051.

The Province has mapped built-up areas and this is reflected in the Region's Official Plan on Schedule A.

The Region and Town will monitor the implementation of the Official Plan policies and development trends. This is done to ensure alignment with Official Plan policies and municipal investment/funding are connected.

Thank you for a clear reply to my questions. You may not appreciate how refreshing that is.

One question and one comment.

1) Would you please quantify what a 50% intensification rate means. Does that mean that over the developed area of Fort Erie that the density has to be increased by 50%? I think that has

a 2051 time frame.

2) What happens if TOFE cannot project meeting your 50%+ target?

Here is the basis of my question: There is a property down the road from me that in the Neighbourhood Plan of 2005 had a target of 17 units on about 3 acres. TOFE has now targeted a minimum of 37 to 75 units – 2 to 4 times greater than before! I understand the technical aspects of this development but the impact on the 12 neighbours bordering this property will be significant. TOFE is justifying this on the principle of 'The Greater Good' - that the harm to these neighbours is justified by the good that adding this extra capacity will bring to the Town. In reality this is about an extra 50 units over what the community was expecting.

I am bluntly at a loss to understand why it is so urgent/mandatory that such an increase in density has to be squeezed in here.

I am not asking you to comment on this development per se. I just want to know what happens if the target is missed by 50 units.

3) The reason I reached out to the Region is that I have trouble getting responses from TOFE Planning.

Thank you for your message. I have provided the below information to address your questions.

1) What is the target that Fort Erie has to reach?

The Region is currently preparing its new Official Plan. Through this work, the Region has identified a minimum 50% intensification rate for Fort Erie. This rate has been endorsed in principle by Regional Council through the Region's land needs assessment.

2) Is Crystal Beach considered part of Fort Erie's targets or do you have a target for CB specifically?

The intensification rate is applied across the local municipality to the already developed areas (also known as built-up areas) to accommodate growth through infill or redevelopment.

3) What documentation have you received from Fort Erie as to how they are going to reach your target?

Local municipalities will use intensification strategies and secondary plans to direct where and how much growth can be accommodated in certain areas of the municipality. These strategies and plans will identify development standards to achieve complete communities and assess requirements to ensure efficient use of services.

I understand that you also recently had discussions with Regional Development Planning staff, including with respect to local planning matters, regarding specific concerns with the proposed development on Rebstock Road referenced in your request. For further information on local planning matters, you may wish to contact the Town's planning department.
