Re: 1361 Rice Road

Thanks for the discussion on your client's interests.

As mentioned, the situation with properties along Rice Road sees the front part of lands being within Pelham and rear portions being within Thorold.

As it stands, portions of lands at the rear (portions in Thorold) were not captured or added to the Greenbelt.

When looking at the context of the area, Regional staff have considered the character of being surrounded by urban areas on three sides and capped with Greenbelt which, for lack of better description, creates a hole in the donut that we believe made sense to recommend as part of the settlement area expansion exercise.

With the image showing the site itself, you can see only a very small portion at the south of your clients lands (blue star) that are not part of the Greenbelt. This is the reason your client received a letter. As you are aware, the Region cannot make changes to the Greenbelt designation, however we can recommend expansion to meet with it. I should also mention considerable environmental lands exist in the larger area proposed to be added and will remain protected into future.

A copy of the draft Official Plan is due out imminently. I can advise there will be site specific policy as it relates to these donut hole lands, as we look to ensure coordination between local municipalities to plan comprehensively despite municipal boundary.
