Further to our zoom meeting of December 15, 2021 Chris had mentioned that all reports pertaining to the settlement area expansion properties would be made available to ensure public transparency. I have just reviewed the Niagara Region Official Plan online mapping tool and did not see any updates for our SABR ID.

Could you please advise if this is the correct location for the public to review all of the associated reports? relating to the Settlement Area Boundary Expansion.

Also I had previously written on December 14th, 2021 relating to two (2) very important Town of Fort Erie reports PDS 14-2021 and PDS 41-2021 that were endorsed by the Town of Fort Erie council and were supportive of our property at 0 Nigh Road (SABR ID #1137).being included from our SABR ID on your online mapping tool.

It appears that you have included these Town of Fort Erie PDS Addendum reports for some properties, but not all properties have been shown the same courtesy. Again i please request that we are provided the same consideration that other properties are being provided to ensure that there is full public transparency for which you have suggested would be undertaken.

I would also like to point out that on Page 13 of Appendix 4 - Niagara Falls and Fort Erie Contextual Review the Fort Erie - Context for Area H you have also excluded our property from this context even though it is in the same neighbourhood and accesses the same features of your preferred properties. The outline for this context stops just north of our property and i am wondering why our property has been excluded again!!

We would appreciate receiving the same consideration as other properties; otherwise i fail to see how this is an objective and transparent process.

I just wanted to bring to your attention a couple clerical issues that i found relating to our property which is identified by SABR ID #1137 0 Nigh Road

- Our meeting request emails are shown as SABR ID #1368 which is incorrect and should reflect SABR ID #1137
- The Niagara Official Plan website contains a mapping tool which provides information on candidate lands respective request for expansion. Each individual property is given a SABR ID number and colour coded on the map predicated by either a municipal request or private landowner request. I have noted that the following two Town of Fort Erie Municipal Reports that relate to SABR ID #1137 are not shown for our respective property, but are shown for other relevant candidate properties.

a) February 22, 2021 PDS-14-2021 UAB Expansion Addendum 1 - Additional Candidate Properties

b) May 31, 2021 PDS-41-2021 UAB Expansion Addendum 2 - Candidate Lands Outside of UBE
